2. You must agree to a background check, if you have a current CHL or LTC all is required is a copy of your current card. For those who do not have a CHL or LTC, a copy of your current Driver License will be required.
3. Applicants must be a member of the NRA, a copy of your card is required.
4. You must read and sign a Release Waiver, all adults will required to sign a release waver and releases for minors will also need to be signed.
5. You must go through a Yearly Orientation. This will be done after all the Membership requirements have been met and your background check is confirmed to be valid.

## ACKNOWLEDGMENT OF RISKS, FULL RELEASE & INDEMNITY AGREEMENT

All forms, rules, instructions, conversations and commands pertaining to Lake Creek Shooting Club ("LCSC") are given in English. Accordingly, I agree and certify that I can speak, read and understand English. I also warrant that I am not a convicted felon and have not been convicted of a charge involving a firearm.

1. I hereby acknowledge that I have voluntarily applied to enter onto and to engage in/or to observe shooting and other activities at the LCSC shooting range (the "Range"). I further acknowledge and understand that the phrase "shooting and other activities" includes any and all activities of any kind whatsoever in which I engage or observe while at the Range, whether sponsored by the LCSC or not.

2. I acknowledge and understand that shooting and other activities involve both known and unanticipated risks of any kind which could result in damage or destruction of property and physical or emotional injury, of me, my guest and/or other persons. The risks include, but are not limited to, being shot, inhalation or other harmful contact with lead or other contaminants, and being struck by flying or falling objects. I accept those risks and will be responsible for my safety and the safety of those in my party and all Range participants as a part of being allowed to participate and or hold membership.

3. I further acknowledge and understand that the nature and condition of the Range facilities, premises and environment is such that both known and unanticipated hazards exist which create or contribute to both known and unanticipated risks inherent in entering onto the Range, in using Range facilities and in engaging in or observing any activities of any kind whatsoever while at the Range. I acknowledge and understand that the LCSC has no duty to undertake first-aid rescue operations or procedures in the event physical or emotional injury occurs. **For emergencies, I understand that it is my responsibility and agree to call 911.**

4. In exchange for being allowed to participate in shooting and other activities on the Range, I expressly agree to accept and assume any and all risks on the Range and in entering onto the Range and in using Range facilities or equipment and in engaging or observing shooting and other activities at the Range. I agree to abide by all LCSC by-laws and Range rules and NRA rules of gun safety and to apply all gun safety rules to the maximum extent possible.

5. Indemnification: In exchange for being allowed to participate in shooting and other activities on the Range, I agree to indemnify, hold harmless, and defend LCSC and officers, directors, agents, and employees, and the owner of the land on which the Range is located from any liability, fault, costs, expenses, claims, or legal actions arising out of or related to my presence, acts, or omissions.

**6. I HEREBY RELEASE AND FOREVER DISCHARGE AND HOLD HARMLESS THE LCSC, ITS OFFICERS, DIRECTORS, AGENTS, EMPLOYEES, CONTRACTORS, VOLUNTEERS, GUESTS, HEIRS, EXECUTORS AND AFFILIATED INDIVIDUALS OR ORGANIZATIONS OF THE LCSC FROM AND AGAINST ANY AND ALL CLAIMS, DEMANDS, DAMAGES, EXPENSES, CAUSES OF ACTION, ATTACHMENTS OF PROPERTY, OR LIABILITY OF ANY KIND WHATSOEVER, FOR INJURY OR DEATH RESULTING FROM ME OR MY GUESTS ENTERING ONTO THE RANGE, FROM USING RANGE FACILITIES OR EQUIPMENT, OR ENGAGING IN OR OBSERVING SHOOTING AND OTHER ACTIVITIES AT THE RANGE, EVEN IF SUCH CLAIMS, DEMANDS, DAMAGES, EXPENSES, CAUSES OF ACTION, OR LIABILITY RESULT PARTIALLY OR WHOLLY FROM ANY ACT OR ACTS OF ANY PERSON, INCLUDING ANY NEGLIGENT ACTS OR OMISSIONS.**

7. I understand that amateur or commercial still, photos, video and/or motion picture photography may occur during my presence on the Range and that I may be incidentally included in such photography. Should I wish to be excluded from such photography, I understand that it is in my responsibility to be aware of photographic activity and remove myself from the area or event being photographed. Absent such action on my part, I hereby grant the LCSC, its sponsors and beneficiaries, the right to use my photographic image in the promotion of the LCSC or shooting sports in general, in accordance with accepted journalistic practice.

8. I further acknowledge and agree that I am a member and that it is my understanding and intent that this agreement, and any signed written amendments or modifications to it, shall remain in full force and effect from the date of execution until I sign another agreement and shall be applicable to each and every occasion that I or any guest of mine enter the Range, use Range facilities or equipment or grounds, or engage in or observe shooting and other activities at the Range.

9. I understand that this document is intended to be as broad and as inclusive as permitted by the laws of the state of Texas and agree that if any portion of this Agreement is invalid, the remainder will continue in full legal force and effect.

I accept those risks on behalf of Minor and acknowledge that Minor will be responsible for Minor's safety and the safety of those in Minor's party and all Range participants as a part of being allowed to participate.

I further acknowledge and understand that the nature and condition of the Range facilities, premises and environment is such that both known and unanticipated hazards exist which create or contribute to both known and unanticipated risks inherent in entering onto the Range, in using Range facilities and in engaging in or observing any activities of any kind whatsoever while at the Range. I acknowledge and understand that the LCSC has no duty to undertake first-aid rescue operations or procedures in the event physical or emotional injury occurs. **For emergencies, I understand that it is Minor's responsibility or the responsibility of an adult accompanying the Minor to call 911.**
6. In exchange for Minor being allowed to participate in shooting and other activities on the Range, I expressly agree to accept and assume any and all risks on the Range and in Minor entering onto the Range and in Minor using Range facilities or equipment and in Minor engaging or observing shooting and other activities at the Range. Minor will abide by all Range rules and NRA rules of gun safety and apply all gun safety rules to the maximum extent possible.
7. Indemnification: In exchange for Minor being allowed to participate in shooting and other activities on the Range, I hereby agree to indemnify, hold harmless, and defend LCSC and officers, directors, agents, and employees, and the owner of the land on which the Range is located from any liability, fault, costs, expenses, claims, or legal actions arising out of or related to Minor's presence, acts, or omissions while on or around the Range.

## Rules and Regulations

1. No shooter or guest shall drink alcohol or use illegal drugs prior to, during, or after shooting while on LCSC grounds.
2. No one under the age of 18 is allowed on range unless accompanied by a parent, guardian or a certified instructor. The parent, guardian or certified instructor is responsible for watching and instructing those under the age of 18.
3. All who enter the range are responsible for reading any posted signs and range warning signs and abiding by all rules and regulations of Lake Creek Shooting Club.
4. Range gates will be closed at all times unless the LCSC is hosting an event.
5. It is the responsibility and obligation of all members to keep the shooting range safe. Report to any executive board member, when a person violates the rules of the shooting range.
6. The LCSC is a cold range. All guns will be unloaded and in a carrying case. This does not apply to law officers. Guns will not be loaded until the shooter is at the firing line.
7. When on the firing line eye and ear protection must be worn at all times.
8. All shooting will stop when the command "Cease fire" is given. All guns with a bolt will be left open and pistols will be put on safety then placed pointing down range. There will be **NO** handling of firearms when there is a "Cease fire". All firearms will be unloaded before anyone goes down range to check targets.
9. No quick drawing or the use of holsters will be allowed on shooting range. The use of holsters will be allowed when running the combat course.
10. All targets must set upright and not be placed on flat ground. Preferable paper target.
11. The use of exploding targets will not be allowed. No tracer or armor piercing bullets will be allowed.
12. The use of full auto or bump stock guns will not be allowed.
13. (50) cal. guns will not be allowed.
14. Shooters will be responsible for picking up their trash. This includes 22 brass.
15. Members are responsible for the guest that they bring. No more than two guest per year.
16. There will be no loaning of cards to other members or nonmembers.
17. If a card is lost or stolen, the card will be replaced at the member's expense.
18. Be courteous; if course is busy please limit your time on the firing line to one hour so others may shoot.
